



Constitution of the International Air Sport Committee (IASC)

Under the International Federation of Municipalities' Sport & Tourism (IFMST)

Article I: Name

The name of the organization shall be the **International Air Sport Committee (IASC)**, operating under the auspices of the **International Federation of Municipalities' Sports & Tourism (IFMST)**.

Article II: Purpose

The IASC is established to:

1. Promote, organize, and conduct Air Sports events in member countries of IFMST.

2. Ensure compliance with the regulations set forth by the **International Federation of Air Sports (FAI)** for all recognized Air Sports.

3. Encourage air sports participation at all levels, from grassroots to professional competitions.

4. Foster international collaboration in air sports as a vehicle for **world peace & harmony** tourism and cultural exchange.

5. Support and enhance the development of air sports infrastructure within member municipalities.

6. Introduce and innovate new air sports for participants ranging from children to adults and regulate them.

7. Introduce and innovate new air sports for kids with a focus on safety.

Article III: Scope of Activities

The IASC shall focus on promoting and conducting air sports events in member countries, including but not limited to:

- Paper Aeroplane Competitions
- Model Aircraft Flying
- Drone Flying Competitions
- Hot Air Ballooning
- Gliding
- Paragliding



- Hang Gliding
- Skydiving
- Aerobatics
- Microlight and Ultralight Flying
- Paratrooping
- Conducting online or live Workshops on Air Sports and related to them
- Conducting Training Lecture Sessions of Air Sports and related to them

The committee shall oversee events at local, regional, national, and international levels in accordance with the FAI regulations.

Article IV: Nominating of IASC for the Year by the Board of IFMST

1. Selection Process:

- A performance-based vote shall determine the IASC for the upcoming year, following the evaluation and decision of the Board of Directors of the IFMST.

2. Nomination of President:

- After selecting the member country to host the IASC for the year, the **President** of the respective country's IASC shall be nominated and declared.

3. Appointments by the President:

- The nominated President shall propose appointments to the following positions for the upcoming year:

- Vice President of the respective IASC
- Secretary-General
- International Relations Officer

Article V: Governance Structure

1. Executive Committee

The IASC shall be governed by an Executive Committee comprising:

- President: Appointed by IFMST.

- Vice President: Nominated by the President of the IASC.

- Secretary-General: Nominated by the President of the IASC; responsible for administrative and operational tasks.







- International Relations Officer: Responsible for coordinating with all associated international institutions of the IASC and IFMST.

- Treasurer: Responsible for all financial matters of the IASC.

- Advisory Members: Representatives from air sport associations, tourism boards, and related stakeholders.

2. Responsibilities of the Executive Committee:

- To formulate and implement policies for air sports promotion.

- To establish Sub-Sport Committees within member countries of IFMST.

- To organize and coordinate events in collaboration with member countries and municipalities.

- To liaise with the FAI for regulatory adherence and recognition of events.

- To develop partnerships with tourism stakeholders to integrate air sports into tourism initiatives.

- To secure sponsorships, manage budgets, and allocate resources for air sports activities.
- 3. Sub-Committees

Sub-committees may be established as needed to address specific areas such as:

- Event Management
- Technical Regulations and Safety
- Training and Development
- Media, Marketing, and Promotion

Article VI: Membership

1. Eligibility

- Membership is open to municipalities, organizations, and institutions under IFMST that demonstrate an interest in air sports promotion.

- National Air Sport Federations recognized by FAI may also participate as advisors.

- 2. Responsibilities of Members
 - To promote air sports and tourism initiatives in their respective regions.
 - To participate in IASC meetings, events, and programs.
 - To ensure compliance with FAI regulations and safety standards in all air sports activities.





- 3. Rights of Members
 - To propose initiatives, events, and projects under IASC.
 - To vote on matters concerning the governance of IASC.
 - To benefit from knowledge sharing, funding opportunities, and promotional support.

Article VII: Responsibilities of IASC

The core responsibilities of IASC under IFMST include:

1. Promoting air sports as tools for tourism, recreation, and skill development.

2. Ensuring that all air sports activities comply with FAI regulations.

- 3. Facilitating the organization of international air sports events in member countries.
- 4. Developing air sports infrastructure and capacity in collaboration with stakeholders.

5. Conducting training programs, workshops, and seminars to advance air sports knowledge and skills.

6. Creating marketing campaigns to attract participants and tourists to air sports events.

7. Establishing partnerships with local and international tourism bodies to align air sports with sustainable tourism goals.

Article VIII: Meetings and Decision-Making

1. General Assembly of Sub-Air Sport Committees:

- The meeting shall be headed by the **President** or **Vice President** of the IASC.

- All IFMST member states' Sub-Air Sport Committees are required to attend online meetings or send representatives.

- The General Assembly shall be held annually to review progress, approve plans, and make strategic decisions.

2. Executive Committee Meetings:

- The Executive Committee shall meet **quarterly** to discuss operational matters.

3. Quorum:

- A quorum shall consist of **two-thirds** of the voting members for decisions to be valid.

4. Voting:

- Decisions shall be made by a **simple majority vote**, except for amendments to the constitution, which require a **two-thirds majority**.





Article IX: Funding and Financial Management

- 1. Sources of Funding:
 - Membership fees.
 - Sponsorships and partnerships.
 - Grants and donations.
 - Event participation fees.
- 2. Utilization of Funds:

- All funds shall be utilized for the promotion and conduct of air sports activities in accordance with the approved budget.

3. Financial Transparency:

- Financial transparency shall be maintained through regular audits and reporting.

Article X: Compliance and Regulations

1. The IASC and its members shall adhere strictly to the regulations and guidelines established by the **International Federation of Air Sports (FAI)**.

2. All safety protocols and standards required for air sports shall be observed in every event or activity conducted under IASC.

Article XI: Amendments

Amendments to this Constitution may be proposed by any member and shall be adopted by a **two-thirds majority vote** during the General Assembly.

Article XII: Dissolution

In the event of dissolution, the assets and records of the IASC shall be transferred to the IFMST for appropriate disposition.

Article XIII: Ratification

This Constitution shall come into effect upon approval by the **International Federation of Municipalities' Sport & Tourism** and its affiliated members.
