Constitution of the International Drone Entertainment and Competitions Committee (IDECC) of IFMST

Article 1: Name and Affiliation

- 1.1 The organization shall be known as the **International Drone Entertainment and Competitions Committee (IDECC)**.
- 1.2 IDECC operates under the **International Federation of Municipalities' Sports and Tourism (IFMST)** as a specialized committee.

Article 2: Objectives

- 2.1 To promote and regulate drone entertainment and competition events within IFMST member countries.
- 2.2 To establish standardized rules, safety guidelines, and ethical practices for drone sports and entertainment.
- 2.3 To foster innovation in drone technology for recreational, competitive, and tourism-related applications.
- 2.4 To encourage youth participation and skill development in drone operations.
- 2.5 To collaborate with international stakeholders, regulatory bodies, and drone enthusiasts to expand global engagement.

Article 3: Membership

- 3.1 Membership is open to IFMST member countries, drone associations, sports organizations, and individuals engaged in drone entertainment and competitions.
- 3.2 Membership categories shall include:
 - **Full Members**: National drone federations and municipal bodies affiliated with IFMST.
 - **Associate Members**: Organizations and individuals contributing to drone entertainment and competitions.
 - **Honorary Members**: Recognized experts and contributors in the field of drone technology and competitions.
- 3.3 Members must adhere to the rules and regulations established by IDECC and IFMST.

Article 4: Governance Structure

- 4.1 Executive Committee:
 - Chairman Leads IDECC and represents the committee within IFMST.
 - **Vice- Chairman** Assists the President of the committee and overseas operations.
 - **Secretary-General** Manages documentation, communication, and administrative affairs.

- **International Relations Officer** Communicate and Represent different geographical areas member countries of IFMST.
- 4.2 The Executive Committee shall be elected every four years by the General Assembly of IDECC members.

Article 5: Meetings and Decision-Making

- 5.1 The Executive Committee shall meet at least twice a year to review progress and strategize future initiatives.
- 5.2 The General Assembly shall convene annually to approve policies, financial reports, and strategic plans.
- 5.3 Decisions shall be made by a simple majority vote, with the Chairperson holding a casting vote in case of a tie.

Article 6: Competitions and Events

- 6.1 IDECC shall organize international drone competitions, air shows, and entertainment events in coordination with IFMST member countries.
- 6.2 Competition categories shall include but are not limited to:
 - Freestyle Drone Shows
 - Racing Competitions
 - Precision and Obstacle Challenges
 - Drone-Based Art and Light Displays
 - Tourism and Cultural Showcases using Drone Technology
- 6.3 Safety regulations and ethical guidelines shall be strictly enforced during all events.

Article 6A: Safety Regulations and Ethical Guidelines

- 6A.1 All participants must adhere to local and international aviation regulations concerning drone operations.
- 6A.2 All drones used in competitions must be inspected for safety compliance before and after each event.
- 6A.3 No-fly zones, altitude restrictions, and designated airspaces must be strictly observed. 6A.4 Pilots must be certified or trained according to IDECC's standardized safety protocols, which include certification from the local aviation authority for drone operations or holding an internationally recognized certification or license. Operators must comply with regulations for flying in urban locations within the designated flying zones as recommended by the respective member country's local or national aviation authorities or other relevant regulatory bodies.
- 6A.5 Use of drones for any unauthorized surveillance, invasion of privacy, or illegal activities is strictly prohibited.
- 6A.6 Emergency response protocols, including fail-safe measures and emergency landing zones, must be established at all event venues.

6A.7 Ethical conduct must be maintained by all participants, ensuring respect for other competitors, audiences, and regulatory authorities.

Article 7: Funding and Financial Management

1. Sources of Funding:

- Membership fees.
- Sponsorships and partnerships.
- Grants and donations.
- Event participation fees.

2. Utilization of Funds:

- All funds shall be utilized for the promotion and conduct of (IDECC) activities in accordance with the approved budget.

3. Financial Transparency:

- Financial transparency shall be maintained through regular audits and reporting.
- 4. IDECC is required to comply with international financial and transaction laws.
- 5. IDECC is required to obtain permission from IFMST for any financial receipts and payments.
- 6.The Treasurer shall maintain transparent financial records and submit an annual financial report to IFMST.

Article 8: Amendments to the Constitution

8.1 Any amendments to this Constitution shall be proposed to the IFMST by the Chairman of the Committee

Article 9: Dissolution

- 9.1 IDECC shall be dissolved only with the consent of the IFMST.
- 9.2 In the event of dissolution, all remaining funds and assets shall be transferred to IFMST.

This statute was approved by IFMST on February 27th after the proposal of the President of IDECC and was notified for implementation.
